

Privacy Policy

AskGreenBit is committed to protecting your privacy and complying with the General Data Protection Regulation (GDPR). This Privacy Policy explains what information we collect, how we use it, and your rights regarding your personal data.



Who We Are

AskGreenBit is a Chrome Extension that estimates the environmental impact of Al conversations. All processing takes place locally within your browser. We do not operate external servers for this extension. If you have questions about this Privacy Policy, you can contact us at info@askgreenbit.com.



What Data We Collect

AskGreenBit does not collect or transmit personal data to external servers. The extension only processes the text displayed on Al chat platforms (e.g., ChatGPT, Claude, Gemini, Grok) to calculate token counts and estimate CO₂ emissions.

Data handled locally may include:

- The number of tokens in your current or past Al conversations.
- \cdot Optional settings you configure within the extension (e.g., energy per token, grid intensity).

This information remains on your device and is stored only in your local browser storage.



How We Use Your Data

- To provide real-time CO₂ calculations for your Al conversations.
- · To display cumulative emissions history (up to the last 10 chats).
- To store your extension settings for accuracy and convenience.

We do not:

- · Send or sell your data to third parties.
- · Use your data for advertising or profiling.
- · Collect identifiable information such as names, emails, or payment details.



Sharing Your Data

AskGreenBit does not share your personal data with any third parties. All calculations and history remain private and local to your browser.



Legal Basis for Processing

Under GDPR, our legal basis for processing is:

- Legitimate Interest Providing users with ${\rm CO_2}$ calculation features that they explicitly request by installing and using the extension.
- **Consent** You provide a consent by installing and using AskGreenBit. You may withdraw this at any time by uninstalling the extension.



Data Security

We take your privacy seriously and apply the following measures:

- All processing is performed locally in your browser.
- · No data leaves your device unless you explicitly copy or export it yourself.
- Browser storage is protected by Chrome's built-in security features.



Data Retention

AskGreenBit retains data only as long as you keep the extension installed or until you clear your browser's storage. You may delete all stored data at any time by uninstalling the extension or resetting settings.



Your Rights

Under GDPR, you have the right to:

- Access information processed by the extension.
- $\boldsymbol{\cdot}$ Request correction or deletion of locally stored data.
- $\boldsymbol{\cdot}$ Withdraw consent by uninstalling the extension.

Since AskGreenBit does not transmit or store personal data externally, these rights are exercised by managing your own extension settings or uninstalling the extension.
